## Agreement and Release of Liability PLEASE READ CAREFULLY BEFORE SIGNING

- I accept for use AS IS the equipment listed on this form and accept full responsibility for the care of equipment while it is in my possession. I will pay the full retail value of any equipment that I do not return. I will pay extra rental fees for any equipment that is returned late.
- Ski Rental: I understand that the ski/boot/binding system is designed to reduce the risk or degree of injuries but will not release at all time or under all circumstances, nor is it possible to predict every situation in which it will release, and is therefore NO GUARANTEE for the user's safety.
- Snowboard/Ski Board Rental: I understand that the binding system cannot guarantee the user's safety. In downhill skiing, and skiboarding with skiboards equipped with release bindings, the binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release. IN snowboarding, cross-country skiing, skiboarding with skiboards equipped with non-release bindings, snowshoeing and other sports utilizing equipment with non-release bindings, the binding system will not ordinarily release during use; these bindings are not designed to release as a result of forces generated during ordinary operation.
- Helmet Rental: If I elect to rent a helmet for the above named minor, I understand that reasonably foreseeable impacts may exceed the protective capabilities of the helmet and it is NO GUARANTEE for his or her safety.
- I understand there are inherent and other risks involved in the sport of skiing, including risks associated with loading and unloading chairlifts, for which this equipment is to be used, and that injuries are a common and ordinary occurrence of the sport and I freely ASSUME THOSE RISKS.
- To the fullest extent allowed by law, I agree to RELEASE, DEFEND, HOLD HARMLESS and INDEMNIFY Soda Springs General Store, their owners, agents, officers and employees (collectively referred to as SSGS) from any and all liability for the damage or injury to myself or to any person or property while skiing, snowboarding, or using the equipment. I agree to be bound by this agreement even if such damage or injury is due to SSGS's alleged NEGLIGENCE in the adjustment or use of this equipment.
- I have made no misrepresentation to SSGS with regard to any information related to the rental and/or use of the equipment.
- This document is a legally binding contract which supersedes any other agreements or representations by or between parties and which is intended to provide a comprehensive release of liability, but it is not intended to assert any claims or defenses which are prohibited by law. The specific rights of the parties may vary from state to state.
